## Background / Current Situation

On March 23, 2020 the Vermont State Emergency Operations Center (SEOC) was fully activated from 0800 to 1600, using a hybrid EOC structure (physical/virtual) with limited in-person staffing at Public Safety Headquarters and State partner representatives working remotely. The SEOC will be fully activated daily until further notice.

## Key Updates from 3/23/20:

- Stay-at-home orders have gone out in the states of Delaware, Louisiana, Massachusetts, Michigan, Ohio, Wisconsin, Indiana, New Jersey, Illinois and California.
- All non-essential businesses have been ordered to close in the states of Connecticut, New York, and Pennsylvania.
- Hawaii has ordered that all persons entering the State of Hawaii self-quarantine for 14 days or the duration of their stay, whichever is shorter.
- The U.S. Department of State issued a global health advisory on 3/19/20, advising U.S. citizens to avoid all international travel. The U.S./Canadian and U.S./Mexico borders are closed to nonessential travel.
- American Red Cross is experiencing a national blood supply shortage.

#### Additional community mitigation measures announced 3/23:

• Gov. Scott has ordered all businesses and non-profits put into place, to the maximum extent possible, telecommuting or work from home procedures effective on Monday, March 23, 2020 at 8:00 p.m.

### Ongoing community mitigation measures:

- Gov. Scott has prohibited in-person operations at close-contact businesses, meaning those
  unable to comply with guidelines for social distancing, specifically: gymnasiums, fitness centers
  and similar exercise facilities, hair salons and barbers, nail salons, spas and tattoo parlors to
  close all in-person operations no later than 8:00 p.m. on Monday, March 23.
- Gov. Scott has further reduced the allowable size of non-essential mass gatherings, now limited

- to no more than 10 people at the same time in a single space.
- Gov. Scott has prohibited the on-premises consumption of food or drink at any bar, restaurant, or establishment. Such businesses can still offer food for take-out or delivery. This prohibition has a tentative end date of 4/6/20.
- Gov. Scott ordered long term care facilities and hospitals to develop policies to limit visitation to reduce facility-based transmission.
- Gov. Scott issued an order allowing beer, wine, and cider purchases with food (for takeout and delivery).
- Gov. Scott issued an order prohibiting in-person transactions at the Department of Motor Vehicles.
- Gov. Scott issued an order for hospitals to postpone elective surgeries.

#### **Health & Medical Branch**

Health & Medical Branch

- Hospitals:
  - Multiple hospitals are anticipating staffing shortages in the coming weeks.
  - Elective surgeries/procedures have been postponed per the Governor's Order.
  - Bed Availability statewide (as of 0900 3/23):
    - 38 ICU
    - 284 Med Surge
    - 53 Isolation
    - 530 Total Beds
    - Of these beds, 120 are negative pressure
- Resources update:
  - PPE supply about the same as yesterday, though not all facilities reporting
- Long Term Care Facilities-many reporting needing PPE but all are operational.
  - As of 3/22, 2,476 of 2,952 licensed beds are filled.
- Activation and status of the Strategic National Stockpile:

- National Guard Support began work at SNS Warehouse today.
- SEOC working with HOC to develop PPE distribution plan.
- SEOC working with HOC to develop medical and health staffing plan.
- Supplies arrived 3/16/2020 being picked and packed according to a prioritization schedule and shipped.
- SEOC working with the Office of the Chief Medical Examiner on fatality management
- SEOC working on policy for relocation of persons for COVID-19 protection.
- COVID-19 Testing:
  - UVM MC doing triage of testing for priority
  - Testing top priority:
    - Health Care workers
    - Long-term Care Facilities
    - Hospitalized patients
  - Collection kits also becoming short in supply
  - Drive-up testing available at Copley, DHMC, North Country, Northwestern, Porter, UVMMC, NVRH Hospitals with variable hours.
  - Potential resource needs PPE, Medical Surge Locations, staffing (VDH currently handling these)
  - VDH Call Center:
    - Current effort working
    - Long term planning ongoing with HOC and SEOC

#### Human Services Branch

- The Department of Corrections coordinated for 6 bedding set-ups (cots and blankets) to be delivered from Northwest State Correction Facility (NWSCF) to Northwestern Counseling & Support Services (NCSS) today.
- Camper units are scheduled to be delivered to the North Branch Campground beginning tomorrow 3/24
- P&P septic lined up to begin sewage removal on Thursday 3/26. They will do a daily pick-up and supply an ADA accessible port-o-let that they will maintain.
- The AHS operations leads are developing a communications plan.
- Feeding, Staffing, and Transportation Plans are all in development.

## Infrastructure & Emergency Services Branch

- The Department of Forests, Parks, & Recreation (FPR) released information to all fire wardens that Town Forest Fire Wardens have the authority to decide whether to issue burn permits or not. FPR doesn't have the authority to issue a statewide burn ban except under extreme fire hazard.
- The Public Service Department (PSD) has released a map of public WiFi hotspots, including libraries, town halls, schools, and SOV buildings with public access to the internet. As a safety precaution, users are discouraged from entering the premises or congregating outside. These sites should be accessed from within a parked vehicle:

#### Supply Chain impacts

- Grocery: No reported changes to Vermont Retail and Grocers' Association (VRGA) Supply Chain Update from 3/21/20.
  - Bread: Worsening situation, suppliers moved to 24/7 production which increased output by 50%, but demand is +200%.
  - Milk: Supply is okay, trucking/logistics is barrier causing out of stocks at stores.
  - Eggs: Supply tightening and cost jumping. Okay for now, but could worsen.
  - Cheese: will take 1-2 weeks to catch up to pre-COVID levels.
  - Paper & Bath Tissue: Continue to get product in quantities much greater than what was sold in prior years. Paper Towels starting to improve.
  - Wipes, Hand Sanitizer, Isopropyl Alcohol: No recovery in sight that will meet demand.
     There will be significantly increased demand going forward.
  - Meat: Continued struggles to secure core proteins; Chicken, Pork and Ground Beef.
     Chicken outlook continues to not look good. Beef outlook is improving.

#### Medical:

- The Agency of Agriculture has received reports from Vermont's businesses who are producing/interested in producing supplies for COVID-19 response including Vermont Glove making up to 50 masks per hour, Vermont Flannel is investigating their ability to produce masks and a Vermont distillery interested in making hand sanitizer.
- Economic injury impact- ACCD staff has recorded over 1,300 interactions with businesses and an estimated loss to date as recorded from those interactions is now \$100 million.
- Unemployment status and rate- No Report.
- Other updates:
  - ACCD is working with SEOC to develop a web form and workflow to intake business inquiries as to their essential or non-essential status.

#### External resource status

- Fulfilled: None reported.

- BGS contracted to have a 275kW generator installed for the St. Albans med-surge facility at Collins Perley. The unit was delivered to the site on 3/23 at 8:30am. The unit will be up and running as soon as the electrician can install a transfer switch, which they are currently trying to procure.
- BGS has identified a contract source for blankets for the St. Albans med-surge facility.

#### Other updates

- BGS is capturing and tracking donation and product/service solicitation information as it arrives. Tracking spreadsheet is uploaded each day to DLAN at the end of the operational period.
- All Vermont Rest Area Facilities are be closed (the parking lots will remain open with portable bathrooms).
- Vermont Agency of Transportation is leading coordination plan for long term Strategic National Stockpile (SNS) delivery operations with Vermont National Guard and Vermont State Police in support of Health Operation Center Logistics. Currently standing by, awaiting request.
- Per a request from the Vermont Retailers & Grocers Association, Department of Motor Vehicles has waived the requirement for five axle trucks to need a special permit to operate at 92,000 lbs without a special permit on State Highways.
- Department of Human Services (DHS) provided guidance on how supervisors should continue to screen employees returning from out-of-state travel using the updated screening tool. Employees returning from travel who are required to stay home for 14 days per VDH guidance or management direction, should telework. If teleworking is not possible, employees should use the time reporting code for COVID-19 paid leave.





## **US School Closures**


