Background / Current Situation

On March 24, 2020 the Vermont State Emergency Operations Center (SEOC) was fully activated from 0800 to 1600, using a hybrid EOC structure (physical/virtual) with limited in-person staffing at Public Safety Headquarters and State partner representatives working remotely. The SEOC will be fully activated daily until further notice.

#### Key Updates from 3/24/20:

- Stay-at-home orders have gone out in the states of Connecticut, Delaware, Hawaii, Louisiana, Massachusetts, Michigan, Ohio, Wisconsin, Indiana, New Jersey, New Mexico, New York, Oregon, Washington, West Virginia, Illinois and California. (See map attached.)
- These jurisdictions also issued stay-at-home orders for their residents: Anchorage, AK; Denver, CO; Boulder, CO; Pitkin County, CO; Miami Beach, FL; Atlanta, GA; Blaine County, ID; Johnson, Leavenworth, Douglas, Wyandotte Counties, KS; St. Louis County, Kansas City and St. Louis, MO; Allegheny, Bucks, Chester, Delaware, Monroe, Montgomery and Philadelphia counties, PA; Davidson County and Memphis, TN; Collin, Dallas and Tarrant Counties, San Antonio and Austin, TX.
- All non-essential or close contact businesses have been ordered to close in the states of Alaska, Georgia, Kentucky, Maryland, Nevada, Virginia, Pennsylvania, and Vermont.
- Hawaii has ordered that all persons entering the State of Hawaii self-quarantine for 14 days or the duration of their stay, whichever is shorter.
- Florida ordered visitors from New York, New Jersey and Connecticut to quarantine for 14 days.
- Kansas ordered those who traveled from California, Florida, Illinois, New Jersey, New York and Washington to quarantine for 14 days.
- Prime Minister of India (more than 1.3 Billion people) has issued a 21-day nationwide stay-athome order.
- American Red Cross is experiencing a national blood supply shortage. Donate if you can!

#### Additional community mitigation measures announced 3/24:

• Gov. Scott has issued an addendum today to ask all Vermonters to "Stay Home/Stay Safe". The order will take effect on Wednesday 3/25 at 5:00pm.

- All business and not-for-for profit entities shall suspend in-person business operations, and are encouraged to develop distance-based services.
- Vermonters are directed to stay at home or their place of residence, leaving only for essential reasons.
- Businesses and entities providing services or functions deemed critical to public health and safety, as well as economic and national security as set forth in the order, shall remain in operation.

#### Ongoing community mitigation measures:

• Gov. Scott issued an order for hospitals to postpone elective surgeries.

### Public Information

- Supported Press Release from National Guard on details of its mission.
- Followed up with reporters about details of Med Surge Task Force and med surge facilities.
- Worked with Agency of Education and Department of Children and Families on media request around availability of childcare for essential workers.
- Developed list of state communicators who can assist with media inquiries and associated agency websites posting COVID-19 resources.
- Department of Public Safety Commissioner Michael Schirling appeared on Vermont Public Radio talking about essential persons list for childcare.

FEMA

Vermont:

- FEMA Stafford Act declaration FEMA-3437-EM-VT was issued March 13, 2020 for the State of Vermont. Eligibility includes Public Assistance Category B: Emergency Protective Measures and Direct Federal Assistance.
- FEMA is actively filling the request for US Coast Guard personnel to the HOC.
- The US Army Corps of Engineers Planning and Response Team has been Mission Assigned by FEMA to support Medical Facility assessments and will support medical surge facility site assessments this week.
- FEMA Region 1 is determining what Strategic National Stockpile (SNS) resources are being pushed nationally.
- FEMA has submitted an Resource Request Form (RRF) for 1 Infection Control Expert for the Health Operations Center.
- FEMA has submitted an RRF at high priority for 4,500 Cepheid Gen Expert Module Test Kits and

associated materials.

Nationally: The National Response Coordination Center in Washington DC is fully activated and adjudicating all federal requests for resources and capabilities from across the Country.

Regionally: The FEMA Region 1 Regional Response Coordination Center (RRCC) is activated to level 2 and is 100% virtual.

Mission & Resource Support

#### Medical Surge

Three medical surge sites are being stood up during the week of 3/23/20. The Vermont Medical Surge Team is working to identify additional sites if needed. Sites currently being set up include:

- Barre, VT
  - Central Vermont Medical Center and the Vermont National Guard coordinating resource allocation and personnel required to make site operational.
- Burlington, VT
  - University of Vermont Medical Center and the Vermont National Guard coordinating resource allocation and personnel required to make site operational.
- St. Albans, VT
  - Northwestern Medical Center and the Vermont National Guard coordinating resource allocation and personnel required to make site operational. Vermont Building & General Services providing logistical support procuring generator for backup power.

Mission and Resource Support Section continually evaluating potential resource needs/gaps and identifying potential sources to fill them.

Logistics Branch

- External resource status Pending:

  - 10 Microbiologists needed for VT Department of Health/ Health Operations Center.
  - 10 Epidemiologists needed for VT Department of Health/Health Operations Center.
- Resource procurement status:
  - Building and General Services (BGS) has ordered 200 ventilators to-date and have access to an additional 12 ventilators.
  - BGS contracted to have a 275kW generator installed for the St. Albans med-surge facility at Collins Perley. The unit was delivered to the site on 3/23 at 8:30am. The unit will be up and running as soon as the electrician can install a transfer switch, which they are currently trying to procure. 100 amps of facility line power is currently feeding the temporary hospital grade wiring. The generator is for back up emergency power and will be fully automatic once the transfer switch arrives. In the interim, it will take about 30 minutes to do a hard wire switch over to generator power should power grid fail.
  - BGS has identified a contract source for 100 blankets for the St. Albans med-surge facility. Blankets are expected to arrive 3/30.

- BGS stood up a donation management group that is working on a spreadsheet of the donations and potential sites for donation drops at various locations.
- BGS Purchasing is finalizing a contract for new source(s) for hand sanitizer from distilleries that are modifying production.

### Economic Development Branch

- Supply Chain impacts
  - Grocery: No reported changes to Vermont Retail and Grocers' Association (VRGA) Supply Chain Update from 3/21/20.
- Economic injury impact: ACCD staff has recorded over 1,300 interactions with businesses and an estimated loss to date as recorded from those interactions is now \$100 million.
- Unemployment status and rate: Department of Labor is creating process to get this updated information to the SEOC.
- Agency of Agriculture is working with Department of Forests, Parks and Recreation to develop a list of sawdust suppliers who can supply dairy farms with bedding.
- ACCD is working with SEOC to develop a web form and workflow to intake business inquiries as to their essential or non-essential status.
- VOSHA is preparing guidance on workplace safety and health complaints as they relate to COVID 19. The Department of Health and the PIO are receiving an influx of employee complaints; VOSHA will address those concerns in broad manner with the press release and then will address each individual complaint that comes in to VOSHA.

#### Infrastructure & Emergency Services Branch

- Statewide power outages are down to approximately 20 outages, which is in the typical dayday range for outages.
- Forest, Parks, & Recreation is working with the Agency of Agriculture to draft a list of sawdust suppliers for dairy farms.
- No reported critical service interruptions due to absenteeism.
- No reported critical infrastructure interruptions due to absenteeism.
- Division of Fire Safety/USAR prepared draft guidance for fire departments awaiting approval.


- Harbor House 50 bed capacity 5 beds in use.



FPR doesn't have the authority to issue a statewide burn ban except under extreme fire hazard.</li> <li>VOSHA is preparing guidance on workplace safety and health complaints as they relate to COVID 19.</li> </ul>
Food, Water, Sheltering	Current Situation	<ul> <li>Per a request from the Vermont Retailers &amp; Grocers Association. Department of Motor Vehicles has waived the requirement for five axle trucks to need a special permit to operate at 92,000 lbs without a special permit on State Highways.</li> <li>Vermont Retail and Grocers' Association (VRGA) has reported increased supply chain issues for the following categories: bread; eggs; wipes, hand sanitizer, isopropyl alcohol; chicken. Not changes have been noted so far.</li> <li>Vermont Food Bank has reported that food shelves are seeing higher than normal visitation. They are able to keep up with the demand for now, but it is notably increased. Their supply limitations are in line with that of grocery stores.</li> </ul>
	Future	<ul> <li>The Community Action agencies are struggling with the task of feeding homeless populations who are being housed in hotels/motels. This is a big change in service for them and is presenting a huge challenge.</li> <li>Schools will need funding to provide snacks to children in child care; schools can provide breakfast and lunch under existing programs, but not snacks.</li> </ul>

Lifelines: Impacts and Actions

**Community Lifeline Status** 

- In the face of limited supplies, testing is being prioritized to hospitalized patients, those in long-term care facilities, and healthcare workers.
- Drive-up testing available at Copley, DHMC, North Country, Northwestern, Porter, UVMMC, NVRH Hospitals with variable hours.
- Approximately 10 asymptomatic and short-term patients of Burlington Health and Rehab are being moved to appropriately adapted rooms at the DoubleTree by Hilton Burlington. This is a cooperative effort by the State, the UVM Medical Center and Burlington Health and Rehabilitation Center to ensure the center's patients can receive the care they need, in comfort, and isolated from further possible exposure to COVID-19. These patients will receive care by UVMMC clinicians and be discharged directly to their home after they are clinically determined to be well enough.
- Three medical surge sites are being stood up during the week of 3/23/20. The Vermont Medical Surge Team is working to identify additional sites if needed. Sites currently being set up include sites in Barre, Burlington, and St. Albans.
- A total of 48 National Guard service members are currently on State Active Duty (SAD) supporting State operations.


