Background / Current Situation

On March 31, 2020 the Vermont State Emergency Operations Center (SEOC) was fully activated from 0800 to 1600, using a hybrid EOC structure (physical/virtual) with limited in-person staffing at Public Safety Headquarters and State partner representatives working remotely. The SEOC will be fully activated daily until further notice.

Key Updates from 3/31/20:

- The SEOC manager is working on submitting a Major Disaster Declaration Request in the coming days.
- There is a new website for Vermonters looking to volutneer: https://www.vermont.gov/volunteer

Nationwide Updates:

- Major Disaster Declarations have been awarded in 24 states, the District of Columbia, Puerto Rico, and Guam.
- 265 million people in at least 32 states, 80 counties, 17 cities, the District of Columbia and Puerto Rico are being urged to stay home.
- President Trump extended Federal social distancing guidelines to 4/30/20, and the CDC issued a domestic travel advisory that urges New York, New Jersey, and Connecticut residents to refrain from non-essential travel for 14 days.

Ongoing Community Mitigation Measures:

- Governor Scott issued Addendum 7 to Executive Order 01-02 on 3/30 requiring any person, resident or non-resident, traveling into Vermont for anything other than an essential purpose, must immediately self-quarantine for 14 days.
 - Visitors are instructed not to travel to Vermont if they are displaying symptoms or if they are traveling from cities and regions identified as COVID-19 "hot spots," including, among others, the states of Florida and Louisiana and the cities of Detroit, Chicago and New York City.

- On-line reservations shall be suspended and lodging providers shall post a prominent notice on their web platforms which advises potential guests that reservations for lodging in Vermont, as allowed, shall be accepted by phone only. Lodging services are only allowable in support of the COVID-19 Response for vulnerable populations or essential personnel.
- Gov. Scott issued Directive 5 pursuant to Executive Order 01-20 Continuity of Learning Planning, on 3/26. This Directive directs schools for preK-12 students to remain dismissed for inperson instruction for the remainder of the 2019-2020 school year. Schools are required to have continuity of learning plans for remote learning implemented on or before Monday, April 13, 2020.
- Gov. Scott has issued an addendum to his executive order to ask all Vermonters to "Stay Home/Stay Safe". The order took effect on Wednesday 3/25 at 5:00pm.
 - All business and not-for-for profit entities shall suspend in-person business operations, and are encouraged to develop distance-based services.
 - Vermonters are directed to stay at home or their place of residence, leaving only for essential reasons.
 - Businesses and entities providing services or functions deemed critical to public health and safety, as well as economic and national security as set forth in the order, shall remain in operation.
 - The Vermont Agency of Commerce and Community Development (ACCD) developed a process for responding to questions regarding acceptable continuation of business operations.
 - ACCD has updated FAQs to help commercial entities, non-profits, employers to selfdetermine if their operations are critical to public health, safety, or economic and national security in Vermont. This FAQ can be found on the ACCD website.
 - ACCD has also developed Stay Home Stay Safe sector specific guidance for businesses.

- Gov. Scott issued an order for hospitals to postpone elective surgeries.
- Restaurants are still able to function, but may only provide curbside pickup or delivery service.

3/30 Call Statistics from 211:

Public Information

The Vermont National Guard took video and still photographs of SNS stockpile warehouse this morning and will make it available to the press online, as requested.

- FEMA is actively filling the request for U.S. Coast Guard or FEMA personnel to staff the Health Operations Center (HOC). Six personnel identified. The Civil Air Patrol has offered resources, which is under review and may be filled without a FEMA RRF.
- The push of Strategic National Stockpile (SNS) resources was received on 29 March.
- Personal Protective Equipment (PPE) orders in the system will be validated against the SNS supplies received.
 - PPE orders through the Resource Request Form (RRF) process going forward will be subject to cost share.
- FEMA submitted an RRF on behalf of the State for:
 - Ventilators: Adjudication will take place nationally, directly with State
 - 1 infection control expert for the Health Operations Center
 - 10 microbiologists
 - 10 epidemiologists
 - High priority for Cepheid Gen Expert Module Test Kits and associated materials.
 - Federal Medical Station Denied

Nationally: The National Response Coordination Center in Washington, D.C. is fully activated and adjudicating all federal requests for resources and capabilities from across the country.

Regionally: The FEMA Region 1 Regional Response Coordination Center (RRCC) is fully activated and is completely virtual.

Logistics Branch

- External resource status -
 - 10 Epidemiologists needed for VT Department of Health/Health Operations Center
 - 10 Microbiologists needed for VT Department of Health/ Health Operations Center
 - 1 Infection Control Specialist for VT Department of Health/Health Operations Center

These requests have been submitted as Federal resource requests and are awaiting approval from Department of Health and Human Services.

- Resource procurement status:
 - Buildings and General Services (BGS) contracted to have a 275kW generator installed at the St. Albans alternate care facility and is waiting for the transfer switch.
 - BGS is working on additional items that are needed for the UVM alternate care facility working with the site manager.
 - BGS is working on the additional PPE and Supplies for the St. Albans alternate care facility.
 - BGS stood up a donation management group that is capturing donation offers and establishing a storage facility for inspection and putting the donations into distribution.
 - BGS is working on establishing catering for meals for isolation/recovery sites and Department of Corrections facilities.
 - BGS is working with the Agency of Human Services (AHS) on facility contracting for isolation shelters for the homeless. The BGS leasing section are leading the efforts to identify spaces across the state for this and other AHS needs. BGS is partnering with AHS providers to eliminate redundancy of effort.
 - BGS has initiated the lease of four refrigerator trailers and are working with the points of contact from each site on location and additional items needed to fulfill the request.

- Additional security and body handling services is being pursued along with additional needs identified for each site.
- BGS has contracted for a mobile tent system for Northeast Vermont Regional Hospital, estimated arrival is between 4/4 and 4/11.

Department of Labor is reporting new claim numbers:

Between March 8 – 14, DOL received ≈ 640 initial claims

Between March 15 – March 21, DOL received ≈ 14,000 initial claims

Total claims between March 8 – March 29 ≈ 45,000 (a 6,000% increase over the prior 3-week period)

Agency of Agriculture

The agency is keeping close eye on dairy price volatility and impact on dairy industry in the months ahead. 645 cow dairy farms are impacted, with concern that large dairy farm attrition will occur without the mitigating effects of auctions and cattle transport.

Infrastructure & Emergency Services Branch

- The Department of Public Service (PSD) reports that broadband service providers are
 monitoring their networks to ensure a consistent user experience and do not anticipate network
 congestion. The PSD is developing guidance for consumers for managing broadband service
 use in homes and businesses to ensure a better experience for important traffic such as
 telehealth video calls.
- The Vermont State Police (VSP) received a delivery of cloth surgical masks and more rigid
 masks along with a donation of masks from an unknown business. These arrived at the Williston
 Barracks and will be sorted through.
- VSP is continuing to monitor absenteeism and disruptions in services for local police departments that may experience staffing problems associated with the COVID-19 pandemic.
- The Division of Fire Safety (DFS) provided feedback of survey results indicating counties'
 capacity to continue providing services. 36% of counties reported experiencing decreased
 availability in the past week, which is not a change from the previous week. Many departments
 are receiving their updates through state sites and emails and Vermont Fire Academy will
 continue to provide direction to established links.

Health & Medical Branch

Health & Medical Branch

- Drive-up testing is available at Putney's Landmark College, Brattleboro Memorial, Copley, Central Vermont, Dartmouth Hitchcock, North Country, Northwestern, Porter, Springfield, Rutland Regional and UVM Medical Center hospitals, with variable hours.
- A major testing push began 3/29/2020:
 - Hospitals and Federally Qualified Health Centers (FQHCs) across the state have new test kits.
 - The Landmark College (Putney, VT) testing site collected specimens starting on 3/29/2020 and is ongoing to fill a gap not covered by hospitals and FQHCs.
- Current hospitalizations:
 - 21 COVID-19 in-patients, up 2 from vesterday
 - 52 Persons Under Investigation (PUIs), up 6 from yesterday
 - 15 COVID-19 patients discharged, no change from yesterday
- Bed availability statewide (as of 0900 3/29):

- 584 total beds, down from 644 yesterday
- 35 ICU beds, down from 53 yesterday
- 307 med surge beds, down from 320 yesterday
- 80 isolation beds, down from 83 yesterday
- Long-term care:
 - One long-term care facility has multiple COVID-19 positive persons and has experienced multiple COVID-19 deaths.
 - One senior living facility has multiple COVID-19 positive persons and has experienced multiple COVID-19 deaths.
 - Vermont Veterans Home is at minimum staffing and has requested staffing support.
- Hospitals are receiving donations of N95s and surgical masks (or hand-made substitutes) from local providers.
- Activation and status of the Strategic National Stockpile (SNS):
 - 8 truck SNS shipment received 3/29/2020.
 - The SEOC created MedLog (Medical Logistics) Branch to support PPE and medical supplies distribution plan on 3/30/2020.
- The SEOC is working with the HOC on fatality management, the relocation of persons for COVID-19 protection, medical & health staffing and infection control plans for various work activities, support of Alternate Care Sites in Burlington, St. Albans and Barre, PPE for Vermont National Guard, N95 fit-testing of responders, and sourcing public health scientists out of https://www.vermont.gov/volunteer web site.
- Testing:
 - The VDH lab received and tested MagMAX Auto extraction kits which allows for additional daily output of tests.
 - The VDH lab implementing training for two new microbiologists
 - The VDH lab received additional testing supplies this morning and is implementing training for two new microbiologists.
 - The lab is looking for U.S. DOT Category B Infectious Materials shipping containers or the equivalent.
 - A web portal will soon be online to efficiently provide testing results to providers.

Childcare program payments are taking longer than usual, expected completion tomorrow. CDD has started coordination with Vermont After school to provide supports for school aged children.
- The Agency of Education (AOE) is releasing updated guidance to superintendents on school calendars and for independent schools. Continuing to work on continuity of operations planning for school food service with Human Services Branch and the SEOC Mission and Resource Support Section.




Vermont Case Count - March 31, 2020





COVID-19 US Cases Over Time


