#### Background / Current Situation

On April 23, 2020 the Vermont State Emergency Operations Center (SEOC) was fully activated from 0800 to 1600, using an almost completely virtual structure, with only call takers stationed at Public Safety Headquarters and all other staff and state partner representatives working remotely. The SEOC will be fully activated daily until further notice.

#### **Key Updates:**

The Vermont Foodbank and the Vermont National Guard will set up and operate Commodity Points of Distribution (CPODs) at state airports in Swanton, North Clarendon, Newport, Bennington, and North Springfield on separate days over the next two weeks. Those in need of food can go to these locations on the appointed days and receive a seven-day supply of Meals Ready-to-Eat (MRE) for each member of their household. Dates and locations are listed below (and on the attached map):

- Wednesday, April 22 Franklin County Airport (Highgate/Swanton)
- Friday, April 24 Rutland Southern VT Regional Airport (Clarendon)
- Monday, April 27 Hartness State Airport (Weathersfield/Springfield)
- Tuesday, April 28 William H Morse State Airport (Bennington)
- Wednesday, April 29 Northeast Kingdom International Airport (Coventry/Newport)

#### **Executive Order Measures:**

On April 17th, Governor Scott announced Addendum 10 which outlines a phased reopening of businesses in Vermont, and mandatory health & safety guidance that will be required of all businesses currently operation and those re-starting:

- The mandatory health & safety requirements for all business operations includes the following:
  - · Not reporting to work if sick
  - Employees must observe strict social distancing of 6 feet while on the job
  - Employees must wear non-medical cloth face coverings over their nose and mouth when in the presence of others.
  - There must be easy and frequent access to soap and water or hand sanitizer during the duration of work, and hand hygiene should be required before entering and leaving job sites.
  - Frequent cleaning/disinfecting of all common spaces.
  - No more than two people shall occupy one vehicle when conducting work
  - Customers and the public in general are strongly encouraged to wear cloth face coverings any time they are interacting with others outside
    their household.
  - Business operations deemed "essential" may continue to operate under pre-existing guidance with the addition of the mandatory health and safety requirements for all business operations outlined above.
- Phased opening of businesses not defined as essential started on April 20th. The business reopening is a phased process that is being driven by ACCD, VDH, and DPS as directed by Governor Scott. Subject to the mandatory health and safety requirements stated above and with some additional guidance, the following operations were allowed to restart:
  - Outdoor Businesses & Construction Operations
  - · Retail Operations; all orders must occur over the phone; no in-store transactions re allowed at this time.
  - Low- or no-contact professional services such as appraisers, realtors, municipal clerks, attorneys, property managers, pet care operators, and others
  - Farmers markets will be allowed to reopen May 1, following guidance currently being drafted by the Agency of Agriculture, Food and Markets.

#### 4/22 Call Statistics from 211:

- 211 received 52 calls, the vast majority from the general public (48 calls).
- The most common call topics were financial stimulus (17 calls), the Stay Home, Stay Safe order (14 calls), and testing (8 calls) (topics are not exclusive, i.e., some calls touch on multiple topics).

#### **Alternate Care Sites**

- One site is currently operable in Chittenden County with four additional sites on standby.
- The Chittenden County site has five patients, with three admissions possible today and no discharges expected today. Total staffed capacity is 50 beds.

#### Long-Term Care Facilities:

- Multiple long-term care facilities have multiple COVID-19 positive persons and have experienced multiple COVID-19 deaths.
- The Health Department Outbreak Prevention Team is proactively working with long-term care and other facilities on infection control, testing and isolation, and recovery preparations or needs.
- An essential employer workplace health and safety and PPE validation effort was finalized to assist those long-term care facilities not engaging in health care
- N-95 sterilization capabilities are extended to health care-oriented facilities by local hospitals that received new Steris V-Pro systems from the state. A letter to skilled nursing facilities (among others) today shared the points of contact for these hospitals.

#### Testing:

- Test kits distributed for testing at multiple nursing homes and a Department of Corrections site are being analyzed starting Thursday 4/23.
- The lab is evaluating a test using a less uncomfortable nasal swab collection process to expand testing in the future.
- The VDH Lab is evaluating stockpiles for testing in summer and fall.

 The VDH Serology Testing Work Group from epidemiology, the labs, and infectious disease providers made recommendations to Commissioner Levine on April 16. No testing is recommended until test reliability improves.

#### Thermometer Update:

No change in status.

#### Other Updates:

- Swabs arrived and were delivered to the Department of Health (VDH) lab.
- Due to a shortage of gowns, orders for gowns will only be filled for facilities dealing with COVID-19 positive patients until the supply is replenished. It is unknown when replenishment will occur. A gown order through the University of Vermont (UVM) is still pending a shipping date.
- UVM committed to delivering surgical gowns, provided by the SNS warehouse at beginning of the response, back to the SNS warehouse by the
  end of this week.
- The branch is pursuing approval to use the Air Guard SNS team members as delivery drivers. Clearance was received today from the SEOC Manager
- RRFs for gowns, goggles, and gloves were split into 16 tickets and separated by size to increase chances of them being filled.
- The branch continues to work with the Data Team on increasing the accuracy of burn rates for facilities.
- The branch, along with the Data Team, started to draft a plan for a Common Operating Picture to assist the Order Team's prioritization of orders.
- A SNS de-mobilization plan specific to procurement has been drafted and is in review.

- Resource procurement status:
  - Four VPro units (for sterilizing used N95 masks) are installed and operational. Four additional VPro units are scheduled to arrive by 5/2/20 and plan has been approved for their distribution.
  - The 4 temporary mortuary sites are set up, if needed.
  - Work continues to identify potential locations and potential costs for a fixed mortuary facility along the OCME preferred route, if needed.
  - The branch is working with the Vermont Department of Health on a facility disinfection plan as part of a statewide procedure for demobilizing sites.
  - Procured the service of a trucking company to distribute frozen meals from Plainfield on 4/27 and 4/28.
  - BGS is working list of hotels for potentially exposed health care workers and first responders if the need arises.
  - The branch procured Bitrex N95 Fit test kits and solution for several organizations in need.
  - BGS is working with the Judiciary on plans for barriers in courthouses.
  - The branch is working with Disabilities, Aging, and Independent Living staff for fit testing of protective masks.
  - The branch submitted an RRF to FEMA for gowns, gloves, and goggles.
  - BGS ordered 6 fans for emergency dental hubs.
  - The branch is working on a laundry service for medical gowns through an existing contract.

#### Staffing Status:

- Hiring for temporary positions, for which interviews were conducted, are on hold (for RN, LPN, case management, and mental health specialist positions).
- Staffing patterns have been developed for the alternate general care sites.
- Staffing patterns are being developed for the alternate sub-acute care sites.
- The branch is working with the Department of Corrections (DOC) nursing on staffing needs.

#### Mass Feeding Status:

- Buildings and General Services (BGS) and the Department of Children and Families (DCF) are working on regional procurement planning efforts. A draft simplified bid is being reviewed.
- Commodity Points of Distribution have been set up for this week and next. The first opened yesterday (4/22) in Swanton and served over 2,600 cases of food (42,240 meals). The second will be in Rutland tomorrow (4/24).
- Several contracts are in place with supervisory unions across Vermont to expand child nutrition programs and support adult nutrition programs.
- The branch is working with the Area Agencies on Aging on executing a distribution plan for 20,000
  frozen meals.

#### **Additional Updates:**

- · AHS finance staff began recovery planning efforts pertaining to the COVID-19 response.
- Disabilities, Aging, and Independent Living (DAIL) continues to provide support to partner agencies, including establishment of skilled nursing sites.
- The Child Development Division initiated a rapid response team with support from 30 staff from the Economic Services Division the Family Services Division to process childcare provider payments.
- 1,127 Essential Persons have completed the online collector form to request referrals for have completed this form for 1,803 children.
   330 Essential Persons requested help for 521 school-aged children, 402 Essential Persons requested help for 560 children under 6, and
   154 Essential Persons requested help for 354 children in both age groups. The remaining 241 Essential Persons representing 368 children did not indicate a need for child care.

#### VERMONT RETAIL AND GROCERS' ASSOCIATION (VRGA):

#### Supply Chain (updated 4/22):

- Bread Supply is available, but in limited varieties. It will likely be 3-4 weeks before the supply fully recovers.
- Flour There is plenty of wheat, but milling capacity is limited. Supplies are catching up with an Easter surge.
- Sugar Stretched milling capacity and a poor sugar beet crop are impacting supply.
- Milk There is ample supply.
- Eggs The supply is improving, and the price is lower.
- · Cheese The supply is improving.
- Paper & Bath Tissue The supply of paper towels is improving, while bath tissue sells as fast as it gets on the shelf. Stores are stocking 40% more bath tissue and 60% more paper towels than in pre-pandemic weeks. Demand continues to be high, but supply is increasing.
- Wipes, Hand Sanitizer, Isopropyl Alcohol The sanitizer supply is improving, but still struggles to meet increased demand.
- Meat The supply is okay for now but will be constrained in the future due to processing shutdowns. The longer-term outlook will depend on how
  fast plants recover. The standard assortment has (and is) challenged, but an extended network of suppliers is meeting the increased demand.
- Produce, Deli, Bakery There is ample supply.
- Pasta/Canned Veggies/Box Prepared Products Supply is coming in regularly and should be improving.

#### AGENCY OF AGRICULTURE FOOD AND MARKETS (AAFM):

- AAFM is developing guidance to enable the safe operation of farmers markets by May 1.
- AAFM is developing guidance for gradual reopening of food and agriculture sectors, beginning with nurseries and greenhouses. Nurseries and
  greenhouses are expected to continue prioritizing telephone or online transactions with curbside pick-up or delivery while gradually resuming
  limited in-person sales to consumers.
- Documenting Economic Impacts AAFM's Business Impacts Survey received 140 responses between March 19 and April 16. While this
  data captures the state of each business at a moment in time, we can see a snapshot of the impact that COVID-19 has had on agricultural
  businesses in our state:
  - Of those 140 businesses, 16% reported closing their business (doubling from 8% last week), 47% reported being partially open, and 37% reported being fully operational.
  - Businesses reported the impact of COVID-19 on their employment ranging from 0-100% loss of employees. The average (mean) loss of employees per business was 26%. Five businesses have indicated hiring additional employees.
  - Businesses reported their estimated economic losses totaling \$13,629,900 from the 120 (of 140) reporting businesses, with a median of \$19,000 per business (increase of \$3,000 per business over last week).
- Milk Dumping AAFM has connected dairy cooperatives, dairy processors and the Vermont Food Bank together to find ways to minimize milk disposal. The partners are reviewing costs and distribution issues this week.
- Meat Processing Vermont processors are operating at capacity with higher demand for services. Many slaughter facilities are booked out
  eight weeks. Nationally, meat and poultry facilities are facing shutdowns due to COVID-19.

#### Emergency Medical Services (VTEMS) -

- The SEOC sent guidance to healthcare workers and first responders on the protocol for decontaminating used N95 masks at local hospitals.
- The supply chain for many types of PPE is seriously constrained around the world. All agencies need to incorporate conservation measures to help reduce the strain on Vermont's supply.
- VTEMS is recruiting and training EMS practitioners to augment COVID-19 testing capability.
- VTEMS is monitoring the impact of crew absenteeism on EMS operations.
- VTEMS is surveying EMS districts weekly regarding COVID-19-related issues, and addressing the issues that come up.
- · VTEMS is developing an online EMS course to ensure continuity of initial EMT training.




# **Vermont COVID-19 Confirmed Cases**

# • On 4/23, the SEOC sent guidance to healthcare workers and first responders on the protocol for decontaminating used N95 masks at • Request approved for Title 32 U.S.C. § 502(f) authorization – allows for

- use of VT National Guard on full-time duty orders. Canada and the US are extending border restrictions for another 30
- days. Nearly 200,000 people cross that border daily in normal times. The EMS Office is developing plans for socially distanced EMS training,
- and is preparing an RFP to support a hybrid education program. Vermont Supreme Court extended the Judicial Emergency until May
- The EMS Office plans to roll out the 2020 EMS protocol update on May
- 15<sup>th</sup>, with all accompanying training available online.

#### Yesterday, the Vermont National Guard distributed 42,240 meals at the Franklin County distribution site in Swanton. The demand was much higher than anticipated. On Friday, VTNG will distribute MREs at the Rutland Southern Vermont Regional Airport in Clarendon.

- ACCD continues to work in close contact with the Vermont Retail Grocers' Association to monitor supply chain issues. As of 4/22, the supply chain is in good shape outside of bread, sugar, bath tissue, sanitizer, and cleaning products which remain strained.
- Farmers markets will be allowed to reopen May 1, additional guidance is currently being drafted by the Agency of Agriculture, Food, and Markets.
- VAAFM is developing guidance for reopening nurseries and greenhouses, as a first step toward reopening the food and agricultural
- VAAFM is working with dairy cooperatives, processors and the Vermont Foodbank to move milk away from disposal and into products for the Foodbank. Costs and distribution issues are being reviewed this week.
- · AHS is working with the Area Agencies on Aging on executing a distribution plan for 20,000 frozen meals.
- The Agency of Education is working on FEMA PA guidance for schools using guidance provided by FEMA, updating continuity of operations for school nutrition directors, and finalizing a family FAQ.
- AOT is staffing border crossings for the State's monitoring of traffic mobility to determine how effective mitigation measures are for reducing travel and also to give healthcare leaders a sense of future healthcare capacity needs. All vehicles (Vermont and out-of-state) are being counted; license plate numbers are not being recorded.

#### **Kev Updates:**

The Vermont Foodbank and the Vermont National Guard began distributing food to those in need in Franklin County yesterday, the first of five locations around the state that will be used for distribution. The National Guard has set up and is operating Commodity Points of Distribution (CPODs) at state airports in Swanton, North Clarendon, Newport, Bennington, and North Springfield on separate days over the next two weeks. Those in need of food can go to these locations on the appointed days and receive a seven-day supply of Meals Ready-to-Eat (MRE) for each member of their household. #### **Executive Order Measures:**

On April 17th, Governor Scott announced Addendum 10 which outlines a phased reopening of businesses in Vermont, and mandatory health & safety guidance that will be required of all businesses currently operation and those re-starting:

- · Phased opening of businesses not defined as essential started yesterday. Subject to mandatory health and safety requirements, the following operations will be allowed to restart:
- o Outdoor Businesses & Construction Operations
- o Retail Operations; all orders must occur over the phone; no in-store transactions re allowed at this time.
- o Low- or no-contact professional services such as appraisers, realtors, municipal clerks, attorneys, property managers, pet care operators, and others.
