Safety and Security	Current Situation	VSP is working with local police departments, the Department of Buildings and General Services, and a sheriff's department on traffic control and security at food distribution sites. The Vermont Supreme Court has extended the judicial emergency through September 1 st . All jury trials in criminal cases are suspended until September 1 st and in all civil cases until January 1 st , 2021.
Safet	Future	 As states begin to lift their restrictions, travel could become more prevalent and lead to an increased risk of virus transmission.
Food, Water, Sheltering	Current Situation	 The combined FEMA Food Box / CFAP food box distribution sites began at the beginning of May. Yesterday the site at VT Route 127 Southbound in Burlington distributed 1,000 CFAP perishable household sets (including Chicken, produce, dairy and milk, and 1,920 boxes (of 15 box-meals) of non-perishable meals. As of 2pm today, the Brattleboro site is estimated to distribute 1,000 CFAP perishable household sets and 2,000 non-perishable box meals. (# not final count) The next meal distribution sites will be held, Thursday, May 28th, 10am-2pm at the Franklin County State Airport, in Swanton, and on Friday, May 29, 10am-2pm at the Caledonia County State Airport in Lyndonville. ACCD continues to work in close contact with the Vermont Retail Grocers' Association to monitor supply chain issues. As of 5/21, the supply chain is in good shape outside of flour and yeast, eggs, paper and bath tissue, sanitizer, cleaning products, and meat.
	Future	The Agency of Education is publishing updated fiscal guidance and meeting with the SEOC Human Services Branch to discuss support for school food service programs. The Child Development Division is developing a statewide distribution plan with the SEOC for cloth face coverings, liquid hand soap, and gloves for childcare centers.
ortation	Current Situation	AOT is staffing border crossings for the State's monitoring of traffic mobility to determine how effective mitigation measures are for reducing travel and also to give healthcare leaders a sense of future healthcare capacity needs. 

Unemployment Compensation (FPUC), an additional \$600 to their weekly benefits through the week ending July 25, 2020. Hair salons and barber shops may reopen 5/29 with limited operations and following mandatory health and safety

- capacity following mandatory health and safety requirements.
