Background / Current Situation

On May 27, 2020 the Vermont State Emergency Operations Center (SEOC) was fully activated from 0800 to 1600, using a completely virtual structure. The SEOC will be fully activated during the week and partially activated through the weekend until further notice.

#### **Key Updates:**

- The next meal distribution will be held on Thursday, May 28 at Franklin County State Airport, 629 Airport Rd, Swanton. The following distribution will be on Friday, May 29 at Caledonia County State Airport, 2107 Pudding Hill Rd, Lyndonville.

#### 5/25-5/26 Call Statistics from 211:

- 211 received 40 calls related to COVID-19 on Monday and Tuesday. Most calls were from the general public (35 calls), and the rest from businesses (5 calls).
- The most common call topics were the executive order (16 calls), testing (16 calls), and travel (12 calls) (topics are not mutually exclusive, i.e., calls can touch on multiple topics).

**FEMA** 

- A Major Disaster Declaration has been approved for Vermont: FEMA-4532-DR-VT
- FEMA is tracking the following Resource Request Forms (RRFs) in progress:
  - Testing materials, including nasal swabs and test tubes
  - HEPA filters
  - PPE including gloves, coveralls, aprons, boot covers, and N95 masks
  - 100,800 remaining boxed meals are arriving this week
  - Powered air-purifying respirators (PAPRs)
- FEMA is procuring donations of Dial soap, cloth face coverings, and bulk sanitizer on behalf of Vermont.

#### **Resource Requests:**

- Meals Ready to Eat (MRE) pickup and delivery has been completed for Waterbury, Pawlet, and Johnson requests.
- The Department of Buildings and General Services (BGS) is coordinating security/law enforcement for pop up testing sites and food distribution.
- BGS is coordinating water, portable restrooms, hand wash stations, and law enforcement coverage for the upcoming food distribution sites.

#### Agency of Transportation (AOT):

- AOT distributed face coverings to state employees in Caledonia County at the St. Johnsbury District Garage today.
- AOT distributed face coverings to state employees in Essex County at the Island Pond District Garage today.
- AOT distributed face coverings to state employees in Orleans County at the Newport District Garage today.
- AOT is providing 100 traffic cones to the temporary testing site at Northshire Civic Center in Manchester.
- AOT is providing 8 traffic cones to the Veterans of Foreign Wars in Brattleboro.
- There are 29 scheduled deliveries of PPE across the state.

#### **Vermont National Guard (VTNG):**

- VTNG is distributing food at various sites across the state with support from AOT. The sites are currently scheduled until May 29th.
- VTNG is providing support to "pop-up" sites for COVID-19 testing across the state.

- Gowns from Saddle Back were received the evening of May 22nd.

- Supply Chain Updates (5/21)
- Bread The supply is good.
- Flour Flour and yeast have limited supply. The demand continues to remain high.
- Sugar The supply is improving.
- Milk The supply is good with no issues.
- Eggs Costs continue to stabilize, though other parts of the supply chain (e.g., packaging) are still working to catch up.
- Cheese The supply is good with no issues.
- Paper & Bath Tissue Demand seems to be lessening, but bath tissue is projected to be limited until September or October. Paper towel supply will improve sooner.
- Wipes, Hand Sanitizer, Isopropyl Alcohol More supply is becoming available, though still slightly limited. Products are still selling quickly.
- Meat Costs are still increasing on a national level and supply will continue to be limited. There will be protein available, just not the variety
  that shoppers are used to.
- Produce, Deli, Bakery The supply is good.
- Pasta/Canned Veggies/Box Prepared Products Varieties are still limited but are slowly improving.




