Background / Current Situation

On April 6, 2020 the Vermont State Emergency Operations Center (SEOC) was fully activated from 0800 to 1600, using a hybrid EOC structure (physical/virtual) with limited in-person staffing at Public Safety Headquarters and State partner representatives working remotely. The SEOC will be fully activated daily until further notice.

Key Updates from 4/6/20:

- The VEM Director has submitted a Major Disaster Declaration and National Guard Title 32 Requests to the Governor's Office for review.
- New guidance has been released advising people to wear cloth face coverings in public settings.

Nationwide Updates:

- Major Disaster Declarations have been awarded in 45 states, four territories, and the District of Columbia.
- This means at least 311 million people in at least 41 states, three counties, eight cities, the District of Columbia and Puerto Rico are being urged to stay home.
- President Trump extended Federal social distancing guidelines to 4/30/20, and the CDC issued a domestic travel advisory that urges New York, New Jersey, and Connecticut residents to refrain from non-essential travel for 14 days.

Ongoing Community Mitigation Measures:

- Governor Scott issued Addendum 8 to Executive Order 01-02 on 4/3 requiring Local governments, state
 agencies and private non-profit organizations, to arrange for non-congregate housing for clients, vulnerable
 populations, first responders and healthcare workers.
 - Non-congregate housing solutions shall be arranged to provide adequate social distancing as needed.
 - A temporary quarantine and isolation program shall be implemented to provide adequate social distancing for those reasonably believed to be have been exposed to or infected with COVID-19, or recovering from COVID-19
 - If needed, non-congregate temporary housing shall be provided for first responders and health care workers who are at reasonable risk of having been exposed to or are infected with COVID-19, or are recovering from COVID-19, and cannot return to their usual residence.
- Governor Scott issued Addendum 7 to Executive Order 01-02 on 3/30 requiring any person, resident or nonresident, traveling into Vermont for anything other than an essential purpose, must immediately self-quarantine for 14 days.
 - Visitors are instructed not to travel to Vermont if they are displaying symptoms or if they are traveling from cities and regions identified as COVID-19 "hot spots," including, among others, the states of Florida and Louisiana and the cities of Detroit, Chicago and New York City.
 - On-line reservations shall be suspended and lodging providers shall post a prominent notice on their web platforms which advises potential guests that reservations for lodging in Vermont, as allowed, shall be

- accepted by phone only. Lodging services are only allowable in support of the COVID-19 Response for vulnerable populations or essential personnel.
- Gov. Scott issued Directive 5 pursuant to Executive Order 01-20 Continuity of Learning Planning, on 3/26. This
 Directive directs schools for preK-12 students to remain dismissed for in-person instruction for the remainder of
 the 2019-2020 school year. Schools are required to have continuity of learning plans for remote learning
 implemented on or before Monday, April 13, 2020.
- Gov. Scott has issued an addendum to his executive order to ask all Vermonters to "Stay Home/Stay Safe". The order took effect on Wednesday 3/25 at 5:00pm.
 - All business and not-for-for profit entities shall suspend in-person business operations, and are encouraged to develop distance-based services.
 - Vermonters are directed to stay at home or their place of residence, leaving only for essential reasons.
 - Businesses and entities providing services or functions deemed critical to public health and safety, as well as economic and national security as set forth in the order, shall remain in operation.
 - The Vermont Agency of Commerce and Community Development (ACCD) developed a process for responding to questions regarding acceptable continuation of business operations.
 - ACCD has updated FAQs to help commercial entities, non-profits, employers to self-determine if their
 operations are critical to public health, safety, or economic and national security in Vermont. This FAQ can
 be found on the ACCD website.
 - ACCD has also developed Stay Home Stay Safe sector specific guidance for businesses. This
 information can also be found on the ACCD website.
- Gov. Scott issued an order for hospitals to postpone elective surgeries.
- Restaurants are still able to function, but may only provide curbside pickup or delivery service.

 - 20% premium on an hour-for-hour basis for hours actually worked when assigned to work in facilities providing care to a COVID-19 positive population or those who are required to deal directly with a COIVID-19 positive individual.
 - Time Sheet Coding instructions will be posted on the DHR website and distributed in the near future

 Temporary, and Exempt employees following a leave plan.




Vermont Case Count - April 6, 2020




New England Cases By County

Guidance for the shortage of used N95 masks has been disseminated to hospitals and first responders in preparation for decontamination. The SEOC is deploying a revised PPE order prioritization system for contingency and crisis standards of care. ACCD is coordinating with Vermont Manufacturing Extension Center (VMEC) and Associated Industries of Vermont (AIV) to identify Vermont manufacturers capable of making non-medical grade face masks.
SEOC is finalizing plans move operations to be fully virtual.
