Background / Current Situation

From July 6 through July 10, 2020 the Vermont State Emergency Operations Center (SEOC) was partially activated from 0800 to 1600 each day, using a completely virtual structure. The SEOC will be partially activated every weekday until further notice.

Key Updates:

- \$30 million in housing assistance to those affected by COVID-19 was announced today. The
 programs use federal CARES Act funding to provide relief for those tenants unable to pay rent,
 landlords suffering from a loss of rent payments and those lower income homeowners needing
 assistance in paying their mortgage.
- On Monday, the Agency of Commerce and Community Development released <u>mandatory</u> <u>guidance</u> for in-person operations at colleges and universities. The guidance seeks to accomplish 3 objectives:
 - 1. Decrease the risk of individuals infected with COVID-19 from entering the campus through effective public health prevention.
 - 2. Decrease transmission of COVID-19 among staff and students once on campus through effective public health measures.
 - 3. Quickly identify individuals with COVID-19 and put containment procedures in place to minimize the impact on students, staff and education.

7/6-7/9 Call Statistics from 211:

- 211 received 135 calls related to COVID-19 on Monday through Thursday. The vast majority of calls were from the general public.
- One of the most common call topics was signing up for food distribution sites.

Public Information

- The Joint Information Center (JIC) posted information about Farmers-to-Families meal distribution, including advice to look for other locations or dates if sites close to those in need are full. The JIC also included information on other feeding resources available around the state.
- The JIC completed a communications plan for encouraging the use of cloth face coverings and provided state agencies with a promotional toolkit. The JIC will share materials with state agencies throughout the month of July and August.

AGENCY OF COMMERCE AND COMMUNITY DEVELOPMENT (ACCD):

- Economic Recovery Grants were launched for businesses that demonstrate revenue loss in any 1-month period from March 1, 2020 to August 31, 2020, when compared with the same month in 2019. Businesses that pay Rooms & Meals Tax or Sales & Use Tax apply through the Department of Taxes. All other businesses apply through ACCD to access these grants. Resource Requests:

 BGS requested permission to draw gloves and masks from the Medical Counter Measures (MCM) warehouse stockpile. The mask order was approved by the SEOC Manager with the distribution of KN-95 masks.

Department of Human Resources (DHR):

- Medical Reserve Corps (MRC) medical volunteer activity:
 - 150 volunteers total, 79 currently activated (no change)

Building and General Services (BGS):

- BGS is working on finding interpreters for food distribution sites.
- BGS is finalizing the procurement of supplemental warehouse space for the public health lab and the MCM Warehouse.
- A recent FEMA delivery of gowns contained the wrong style of gowns, leading to a shortfall of Level IV waterproof surgical gowns for the strategic stockpile. BGS is currently searching for options to make up this shortfall.
- The Office of Purchasing and Contracting (OPC) ordered N-95 masks that will arrive in 2 weeks OPC is following up to double check the arrival and looking into other supply chain options.

Vermont National Guard (VTNG):

- VTNG is supporting pop-up testing sites.
- VTNG is supporting food distribution.

• SerVermont is working on finding volunteers for August food distributions, working alongside Hunger Free Vermont and its affiliated Vermont Hunger Councils.

Other Updates:

- The branch is set to support the Office of the Vermont Secretary of State, to provide PPE for election operations.
- The branch participated in a COVID-19 vaccine planning call on Thursday, 7/9.
- The branch provided a PPE report to the governor, including the 180-day projections for PPE needs.
- The Department of Buildings and General Services requested that the branch consider a more formal communication with the Agency of Education (AOE) about sourcing their own masks. The branch is currently waiting to receive policy guidance from AOE.

Southeast wind 8 to 10 mph becoming south in the afternoon. Chance of precipitation is 60%. New rainfall amounts between a quarter and half of an inch possible.

- Saturday Night: Showers likely, mainly before 9pm. The rain could be heavy at times. Mostly cloudy, with a low around 68. South wind around 7 mph. Chance of precipitation is 60%. New precipitation amounts between a tenth and quarter of an inch possible.
- **Sunday:** A 50 percent chance of showers. Partly sunny, with a high near 84. South wind 9 to 13 mph. New precipitation amounts between a tenth and quarter of an inch possible.
- **Sunday Night:** A 30 percent chance of showers. Partly cloudy, with a low around 64. Southwest wind 3 to 7 mph. New precipitation amounts of less than a tenth of an inch possible.

Tropical Storm Fay

- Tropical Storm Fay is expected to lift northward and track towards Interior New England and New York by Saturday morning. The main impacts will be the potential for a swath of locally heavy rainfall to cross the region overnight until mid/late morning Saturday. The higher rainfall rates in a short period of time (towards Saturday morning) could produce localized flooding and bring smaller creeks and streams to bank-full. Otherwise, most will not witness any flooding.
 - Greatest rainfall is expected across portions of northern NY and VT's Southern Green Mountains where 1 to 2 inches is possible.
 - Localized amounts approaching or exceeding 2.5 inches may lead to localized partial "gravel"
 - washouts and may cause streams to reach or exceed their banks
 - Additional scattered showers and thunderstorms with locally heavy rainfall is possible Saturday afternoon.

 - Reservations are required for the distributions. Register online or call 211 if there are internet issues.
 - On 7/6 through 7/9, 2,546 sets of food were distributed at 12 sites.
 - On 7/10, 669 sets of food were reserved at 3 sites (the number reserved tends to be slightly higher than the number actually distributed).
- The application for an Economic Recovery Grant is open to Vermont businesses. With funding available to the State of Vermont through the federal Coronavirus Relief Funds, these grants are intended for businesses who can demonstrate revenue loss in any one-month period from March 1, 2020 to August 31, 2020, when compared with the same month in 2019. Some 3,600 applications have been received
- On 7/3, the Division for Historic Preservation announced that Vermont State Historic Sites are open on a limited basis.
- · Buildings and General Services is working on finding interpreters for food distribution sites.
- The Agency of Education is developing FAQs and sourcing supplies to support school reopening.
