

### *Background / Current Situation*

On July 1, 2020 the Vermont State Emergency Operations Center (SEOC) was partially activated from 0800 to 1600, using a completely virtual structure. The SEOC will be partially activated every day until further notice.

---

#### **Key Updates:**

- Governor Phil Scott, the Agency of Commerce and Community Development (ACCD), and Department of Taxes today announced Vermont's Economic Recovery Grant Program will launch on July 6, 2020. The grant program first proposed by the Administration and amended by the legislature utilizes federal CARES Act funding to provide direct cash grants to Vermont businesses who have seen lost revenue because of COVID-19.
- The initial wave of money available for grants will be \$50 million administered through the Department of Taxes for businesses who pay rooms and meals or sales and use tax. An additional \$20 million will be available to all other private businesses and non-profits through ACCD. The grants will be allocated on a first-come, first-serve basis.
- Eligibility requirements include:
  - ◊ Business was open and active before February 15, 2020.
  - ◊ Business is open at the time of application or is required to have closed due to COVID-19 restrictions but can certify to its intention to re-open when the COVID-19 restrictions are lifted.
  - ◊ Business has experienced a 75% or greater drop in total revenue in any one-month period from March 1, 2020 to August 31, 2020, when compared with the same month in 2019.
- The amount of the grant will be derived by the following formula:
  - ◊ Indicated/reported gross annual revenue (or annual combined total sales as reported on meals and rooms or sales and use tax returns) multiplied by 10 percent.
  - ◊ The maximum grant ceiling amount is \$50,000.
  - ◊ Each business or organization applicant may only receive one grant.

- Please note, these conditions were added by the legislature in Act 115; the executive branch must adhere to the parameters set in legislation, but they were not part of the Governor's initial proposal.
- All businesses are strongly encouraged to visit the Recovery Grant Resource Center prior to July 6th for full details of the program, eligibility requirements, and documentation that will be needed with applications. - A second wave of grant monies is expected, when [H.966](#) reaches the Governor Scott's desk. While that money has different parameters and carve outs, ACCD will use this same system for processing those grant applications.

\*\*Includes close contacts who are being monitored in Sara Alert, which provides free daily symptom check reminders for 14 days while they are quarantining. People who are identified as close contacts of people with COVID-19 are enrolled unless they opt out.

**6/30 Call Statistics from 211:**

- 211 received 35 calls related to COVID-19 on Tuesday. The vast majority of calls were from the general public.
- The most common call topics were *Be Smart, Stay Safe* (10 calls), Finding a Doctor (9 calls), and travel (7 calls). Topics are not mutually exclusive, i.e., calls can touch on multiple topics.

*Public Information*

- Finalized content related to the Farmers to Families food distribution program. Beginning to disseminate information on the website and social media.

- Continuing strategy planning in conjunction with AHS and other state communication teams for publicizing the use of face coverings by the public.

- Space has been secured for the Public Health Lab to move into a suite adjacent to the Medical Counter Measures (MCM) Warehouse for Test Kit assembly. Medical Logistics Branch and Buildings and General Services (BGS) are working to expand MCM Warehouse space, awaiting final confirmation.
- Medical Logistics Branch working with Vermont Air National Guard for Test Kit assembly staffing support; availability is not yet confirmed.
- BGS is working on procurement of PPE to augment current supply for an up to 180-day stockpile strategy and working with multiple vendors as well as FEMA and UVMCC.

**Resource Requests:**

- No requests pending requests or unmet needs.

**Department of Human Resources (DHR):**

- Medical Reserve Corps (MRC) medical volunteer activity:
  - 146 volunteers total, 75 currently activated (no change)

**Building and General Services (BGS):**

- BGS is working on finding disinfecting wipes and thermometers for the Urban Search and Rescue (USAR) Team.
- BGS is finalizing the procurement of supplemental warehouse space for the Public health Lab and the MCM Warehouse.

**Vermont National Guard (VTNG):**

- VTNG is supporting pop-up testing sites.
